# 2. Introduction

For movements to a place of direct delivery in Austria according to article 17(2) of Directive 2008/118/EC and Regulation 684/2009/EC it is possible to use a code replacing the address data in boxes 7c, 7e and 7f of the electronic administrative document (box "Trader Place Of Delivery" of the e-AD).

To obtain a direct delivery code it was necessary until now to upload a CSV- or TXT file with the address(es) of one or more places of direct delivery on the website https://vst.bmf.gv.at/emcs-multi/pages/bmfDirectDelivery?execution=e1s1

Additional information is required to receive a direct delivery code.

The new required information is as follows:

- Labels of columns and rows (to avoid misleading data).
- Name, address and e-mail address of the person who applies for encoding a place of direct delivery (for authentication purposes).
- A self-chosen validation code for possible subsequent corrections. The validation code has to be chosen by the person who applies for encoding a place of direct delivery.

If you want to correct or to complement the data concerning some already transmitted places of direct delivery, it is necessary to enter the ARC or the direct delivery code.

The corrected/complemented file has to comply with all formal requirements and has to contain the same validation code which has been used for requesting the code.

Please not all formal requirements mentioned under Par. 2.1.

# 2.1. Formal Requirements

#### **2.1.1. CSV format**

If the places of direct delivery should be uploaded in a CSV file, only the file format CSV (Comma delimited) (\*.csv) may be used.

### 2.1.3. Global provisions:

- Labels of columns and rows
  - o These texts may not be modified. Otherwise the file will not be accepted.
- Green: Mandatory data
  - o These fields must be filled; else the file will not be accepted.
- Yellow: Optional data
  - These fields may be left empty.
  - o If these fields are used, then the mandatory fields of the concerned row must be used too.

### 2.1.4. Characteristics of rows with the label "Further delivery address":

Any number of rows with the label "Further delivery address" may occur. Thus it is possible to create a template for files with any number of places of direct delivery.

Not used rows with the label "Further delivery address" must be empty at all (see row 8 and 9 of the chart above).

It is not allowed to use rows bellow an empty row.

### 2.1.5. Fields and their content

- Contact (the contact person or company is mandatory)
  - Name and address of the person or company, who applies for encoding (a) place(s) of direct delivery.

Fields to be filled in

- name
- street
- street number
- post code
- city

#### e-mail-address

o An e-mail-address of the person or company who applies for encoding (a) place(s) of direct delivery is mandatory.

#### Validation code

- o This number has to be self-chosen
  - It is at one's own discretion to change the validation code:
    - at each delivery
    - or after a certain period
    - or never

Concerning this no regulations from the MOF are in place. Principally it is recommended to change any password periodically.

- This validation code is necessary for data correction (repeated upload of a corrected CSV file). The same validation code has to be used as for the initially uploaded file.
- The validation code must be composed of four numerical digits.
- The first digit of the validation code should not be 0 (zero)

#### First delivery address

- The first delivery address is mandatory
- o Fields to be filled in
  - name (optional)
  - street (required)
  - street number (optional)
  - post code (required)
  - city (required)

#### Further delivery address

If there are more than one place of direct delivery the first delivery address is mandatory anyway. The declaration of further places of direct delivery is mandatory in case these places are not stored in national SEED as places of direct delivery of the registered

Since other economic traders who are not registered consignees themselves are not aware of the places of direct delivery of the registered consignee in national SEED it is mandatory to provide all places of direct delivery of a consignment.

If there are no further places of direct delivery mentioned the consignment under excise duty suspension arrangements is deemed to be closed at the first place of direct delivery.

- Fields to be filled in
  - name (optional)
  - street (required)
  - street number (optional)
  - post code (required)
  - city (required)

### 2.1.6. Example file in TXT-format:

In the text file the fields have to be separated by semicolons. All requirements and validations concerning CSV files apply mutatis mutandis to TXT files.


# 4. Changes on Website


# 4.1. Selection Direct delivery code or ARC

If you want to correct or to complement the data concerning some already transmitted places of direct delivery, you have to enter the ARC or the "Direct delivery code" to correct/to complement the consignment.

To avoid the entry of one of these two codes (direct delivery code or ARC) into the wrong field the kind of code has to be chosen with the radio buttons.

In this way just the field for the chosen code is enabled.





# 4.2. Reset of form

After each successful encoding or after each error message the form has to be reset. For this purpose please press the "Rest" – button at the bottom end of the website. Only then all input fields are enabled again.
